Notification Letter (PNL) Requirements for Automatic Dependent Surveillance-

Broadcast (ADS-B) Out Certification Projects

Memo No.: AIR100-15-140-DM37

This memorandum provides additional information regarding the requirements for ADS-B out organizational delegation authorization (ODA) certification project PNLs. Memorandum AIR100-15-140-DM30 provides a deviation from Order 8100.15B, section 11-7.a.(7), allowing ADS-B out ODA certification projects to be conducted without submittal of a PNL.

As noted in the memorandum, the coordination requirements of Order 8100.15B, section 11-7.a.(7), still apply to certification projects conducted without submittal of a PNL. Thus, Certification Project Notifications (CPN) must be completed for all supplemental type certifications (STC) and STC amendments. The ODA procedures manual must prescribe when and how CPN information will be submitted to the aircraft certification office for entry into the national CPN database. The project should be identified as a "No PNL ODA Project" in the project description field of the CPN database.

Additionally, as currently allowed by Order 8100.15, section 11-7.a.(7)(b)7, projects adding models to approved model list (AML) STCs may be accomplished without submittal of a PNL. However, any projects for issuance of a new AML STC require submittal of a PNL.
