Subject:	Deviation to FAA Order 8000.95, <i>Designee Management Policy</i> , Volume 8, Chapter 7, Paragraphs 3a(1)(b) and 3b(2)(b), Initial and Recurrent Training Requirements for Designated Manufacturing Inspection Representatives (DMIR) and Designated Airworthiness Representatives – Manufacturing (DAR-Fs)

This memorandum approves a deviation to FAA Order 8000.95, volume 8, chapter 7, paragraphs 3a(1)(b) and 3b(2)(b), by authorizing new initial and recurrent training requirements for DMIR and DAR-Fs. These new training requirements are effective October 1.

Two of the previously required courses in initial and recurrent training will be replaced with three new required courses. The two previously required courses being replaced are the "Initial Aircraft Engines, Propellers, and Articles" seminar for applicants desiring authorization to certify anything other than an aircraft, and the "Recurrent Aircraft Engines, Propellers, and Articles" seminar for DMIRs and DAR-Fs authorized to issue domestic and export approvals of aircraft engines, propellers, and articles.

The three new courses required for initial and recurrent training are as follows:

- 1. "Issuance of FAA Form 8130-3, Airworthiness Approval Tag/Authorized Release Certificate for Domestic Approvals and Export Approvals of Engines, Propellers, and Articles ONLY." This new course replaces both the initial and recurrent "Aircraft Engines, Propellers, and Articles" seminars. This new training course is for DMIR and DAR-Fs.
- 2. "Initial Conformity Determinations" seminar. This seminar includes an online and a classroom portion, and is intended for those applicants desiring to conduct conformity activity. This new training course is for DMIR, DAR-Fs, and Organization Designation Authorization (ODA) manufacturing unit member (UM) applicants.



 "Recurrent Conformity Determinations" course. This is an online course for DMIR, DAR-Fs, and ODA UMs currently authorized to conduct confomity activity.

ODA holders utilizing the training guidelines in FAA Order 8100.8, *Designee Management Handbook*, may also take advantage of this training for their manufacturing UMs.
